Step #3 - Terms and Conditions of Membership (Primary Member Must Sign)

Workdays

We perform our own maintenance and repairs to our riding areas. Every member age 12 or older must meet the membership work requirement (currently two 4-hour work days annually) in order to maintain their eligibility to ride. Workdays can be completed any time during the year, and members can ride prior to the workdays being completed. The workdays must be completed by the end of the year. Members may pay \$50 instead of completing their required workday.

Acceptable Behavior at Club Facilities, Club Events, and Online

Members are required to behave in a safe and respectful manner at all times at club facilities, on the club's website and Facebook page, or while acting as a member of the club. This includes:

Wearing the required protective gear: helmet, motocross goggles (over glasses if glasses are necessary), gloves, over-the-ankle boots, long pants, and long-sleeved shirt) whenever you are riding. Additional protective gear (chest protector, knee guards, elbow guards, etc.) are encouraged. Ride supervisors are instructed to ask you to leave if you do not have the required protective gear.

Riding safely. This is a family club focused on providing riding opportunities for riders of all skill levels. Most days, you'll likely have a lot of space to ride at whatever pace you'd like. However, when you are on the track or trail with others of lesser ability, it is <u>your</u> job to adjust your riding to take into account the safety of the least capable riders sharing the track with you. <u>If a ride supervisor requests that you adjust your speed or style for that day's conditions or rider count, you are required to follow their guidance.</u>

Treating other members respectfully, both in person and online. This is family club. Avoid confrontations and arguments including online conversations in the FORPWC group email. Additionally, please keep conversation topics appropriate for the family nature of the club and avoid using inappropriate language. Slandering, name calling, threats, and vulgar language will not be tolerated.

Punishments, such as suspension or expulsion, are determined by vote by your fellow club members.

Non-members at Club Facilities

Insurance regulations & lease agreements do not allow non-members on any of our Riding Properties, even if they are not riding. You are <u>not</u> permitted to bring a non-member with you to any of the club's facilities, unless you have purchased a guest pass and they have signed the required insurance waiver (guests under 18 require a parent and a notarized waiver).

Non-refundable Dues

Membership dues are not refundable under any circumstances.
